

## **A Bill to Build Additional Prisons**

BE IT ENACTED BY THE CONGRESS HERE  
ASSEMBLED THAT:

**Section 1:** Two additional prisons will be constructed in each State.

**Section 2:** The United States Department of Corrections will be responsible for the following: Site location Prison design Technology necessary to keep prisoners safely secured within the new facilities.

**Section 3:** Additional prisons will be built to replace any prisons that plan to close.

**Section 4:** Site location will begin within 30 days; construction will begin within 6 months and new prison construction will be completed within 30 months of the passage of this legislation.

**Section 5:** All laws in conflict with this legislation are hereby declared null and void.

# **A Resolution to Amend the Constitution to Allow Naturalized Citizens to Run for President**

**WHEREAS**, More than 200 years ago, our founding fathers didn't want foreign nobles moving to America and using their fortune to buy their way into public office; and

**WHEREAS**, as a result, the U.S Constitution mandates that the President of the United States is a natural born citizen; and

**WHEREAS**, there is no similar pre-requisite for service in any other elected or appointed position in the Federal Government; and

**WHEREAS**, this requirement has precluded many qualified and patriotic individuals from running for President, such as Henry Kissinger, Fareed Zakaria, or Madeliene Albright; now, therefore, be it

**RESOLVED**, That the Congress here assembled propose an amendment to Article Two, Section One, Clause 5 of the U.S. Constitution from, “No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution shall be eligible to the Office of President” to “Any Natural Born Citizen of the United States or any Immigrant that migrated to the United States before the age of 15 and has been a citizen and lived in the United States for at least 20 consecutive years qualifies to fill the Office of President” and, be it

**FURTHER RESOLVED**, any candidate for the Office of President must meet all other necessary requirements present in the U.S Constitution and to be eligible for the position of President

## **A Resolution to Fortify German Influence to renew US-European relations and save the EU**

**WHEREAS**, The EU is currently under enormous strain to stay together in the face of the rift between German austerity and French state-industry economic models; and

**WHEREAS**, The dissolution of the EU would mean the collapse of numerous Western European economies and governments friendly to the US; and

**WHEREAS**, Political extremism and rioting have become widespread within the EU undermining US-EU relations; and

**WHEREAS**, The German economy is the largest and most stable of all the economies in the European Union; and

**WHEREAS**, German economic interests are more in line with US economic interests than the French alternative, and

**WHEREAS**, Germany has the most powerful economy in the EU, and **WHEREAS**, Promoting German influence over peripheral states would make stabilizing the entire EU less difficult by the immense over-reach of German economic influence; now, therefore, be it

**RESOLVED**, That the Student Congress here assembled strengthen economic and political ties to Germany to stabilize the EU; and, be it

**FURTHER RESOLVED**, That the US reallocate 3% of all forms of foreign aid from current recipients to failing European states to secure German-US influence.

# **A Bill to Save American Lives by Protecting Medicine**

BE IT ENACTED BY THE CONGRESS HERE  
ASSEMBLED THAT:

**Section 1:** Congress will grant the Food and Drug Administration(FDA) emergency power to order pharmaceutical corporations to increase production of life-saving drugs, specifically the drug methotrexate.

**Section 2:** The FDA will be able to engage this emergency power for a span of up to nine months. This emergency power will allow the FDA to forcefully change the production plans of companies who produce the drug to increase the supply of said drug.

**Section 3:** All company production takeovers will be done with the direct oversight of the FDA director and Secretary of Health and Human Services. If the emergency cannot be averted within the nine-month period, executives of the companies involved will meet with the House Subcommittee of Health to determine a long term plan to ensure an ample supply of these vital drugs. Any company that comes under the control of the FDA will receive reimbursement for any losses in the form of tax breaks and subsidies.

**Section 4:** This law will take effect on immediate passage.

**Section 5:** All laws in conflict with this legislation are hereby declared null and void.
