

**Bill to Amend the National Defense
Authorization Act for Fiscal Year 2012**

**BE IT ENACTED BY THE CONGRESS HERE
ASSEMBLED THAT:**

SECTION 1. Section 1021(e) is removed from the Act in its entirety.

SECTION 2. Section 1022(b) is removed from the Act in its entirety.

SECTION 4. This law will take effect immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban Prescription Drug Advertisements

BE IT ENACTED BY THE CONGRESS HERE
ASSEMBLED THAT:

SECTION 1. All direct to consumer (DTC) advertisements for prescription medications in the United States are hereby declared illegal.

SECTION 2. Each violation of this legislation is subject to a \$250,000 fine requiring payment within the fiscal year said violation occurs.

SECTION 3. The Federal Communications Commission (FCC) in conjunction with the Food and Drug Administration (FDA) shall enforce this legislation.

SECTION 4. This law will take effect within 12 months of passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Guarantee Full Military Support of Turkey

WHEREAS, Turkey finds its territory, citizens, and sovereignty threatened by external aggression; and

WHEREAS, the United States and Turkey are member states of the North Atlantic Treaty Organization (NATO); and

WHEREAS, NATO member states agree to mutual defense in response to an attack by any external party; and

WHEREAS, at least one occurrence of such attack has occurred on Turkey's border with Syria; and

WHEREAS, prevailing circumstances in Syria point to strong potential for further violence; now, therefore,

BE IT RESOLVED, by the Student Congress here assembled that the United States guarantees the full support of its Armed Forces in any threat to the territory, citizens, and sovereignty of Turkey.

A Resolution Mandating Organ Donation without Prior Consent

Whereas, hospitals in the United States are crippled by the absence of viable donor organs of all kinds available in critical situations and on short notice; and,

Whereas, viable donor organs are currently available for harvesting from deceased individuals who have neither declared themselves organ donors nor declared in writing their refusal to donate organs upon death; and,

Whereas, deceased persons cease to maintain virtually all legal rights upon death; and,

Whereas, the needs of society will be served by presuming consent to organ donation in the absence of a written declaration to the contrary; and,

Be It Resolved by the Student Congress Here

Assembled that in critical care situations wherein no donated organ(s) is/are reasonably available for transplant, and organ transplant is reasonably necessary to prevent patient death, all hospitals shall be permitted to harvest organs from otherwise viable donors in the absence of an advance express written declaration executed by the deceased from whom the organ(s) is/are sought, and all hospital administrations approving such harvesting shall be indemnified and held harmless from legal liability should legal action be commenced related to the harvesting of any and all organs.

A Bill to Recycle Nuclear Weapons

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

SECTION 1: Any nuclear warhead over the age of 35 years shall be recycled, and its fissionable materials diverted to energy production.

SECTION 2: The Department of Defense (DoD) in cooperation with the Department of Energy (DoE) shall oversee transition of materials from military to civilian uses.

A. The DoD shall identify weapons for recycling, and oversee transportation and security of all weapons-grade materials.

B. The DoE shall identify reactors that can use MOX and other recycled fuels, and negotiate contracts for payment and delivery.

SECTION 3: When no site within the contiguous United States will accept recycled warhead fuel, the DoE may negotiate delivery and sale to Canada, France, Japan, or the United Kingdom.

SECTION 4: Monies shall be made available in the FY 2013 budget for the initial planning and reorganization required, and may be renewed through the normal channels.

SECTION 5: Recycling of warheads shall begin within six month of passage.

SECTION 6: Recycling program shall be suspended at such time as the nuclear arsenal falls below 4000 warheads or by Executive Order in time of war.

A Binding Resolution on Congressional Ethics

WHEREAS, Members of the Congress are privy to business and financial information unavailable to the general public; and

WHEREAS, The Securities Exchange Act regulates the use of nonpublic “inside” information by corporate officers, their families, and their business associates, but not by elected officials; and

WHEREAS, Members of Congress who actively manage their stock portfolios achieve returns from 10-25% greater than the average American does; now, therefore, be it

RESOLVED by the Student Congress here assembled, that we do subject ourselves to the terms of the Securities Exchange Act and the rules established by the Securities Exchange Commission, regarding the ethical use of nonpublic information obtained in the execution of our duties.

A Bill to Suspend Aid to Egypt

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. In light of the decrees issued by President Mohammad Morsi, no American military aid funds shall be given to Egypt. A. Any funds received by the Egyptian Armed Forces shall be withdrawn, while humanitarian aid remains unchanged.

SECTION 2. USAID, the Department of Defense, and other organizations that give aid are to enforce this legislation.

SECTION 3. This legislation shall be implemented one month after passage.

SECTION 4. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Repeal the Use of Daylight Savings Time

Whereas, Several States and Territories do not recognize Daylight Savings Time (DST); and,

Whereas, DST causes a loss of productivity during the adjustment to the time changes; and,

Whereas, the time changes often cause severe changes in the human sleep cycle; and

Whereas, any energy savings attributed to DST are often offset by increases in heating, cooling, and gasoline costs; therefore,

Be it resolved by the Student Congress here assembled that the United States should repeal the use of Daylight Savings Time.

A Bill to Establish a National Climate Service
BE IT ENACTED BY THE CONGRESS HERE
ASSEMBLED THAT:

SECTION 1. The National Oceanic and Atmospheric Administration shall consolidate its climate monitoring capabilities under a single service, henceforth known as the National Climate Service.

SECTION 2. The Department of Commerce and its subagency, the NOAA, shall be responsible for implementing the consolidation.

SECTION 3. Funding for all NOAA climate monitoring capabilities shall be redirected to the National Climate Service.

SECTION 4. This legislation shall be implemented immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution Regarding the Free School Guarantee

WHEREAS, public education is guaranteed as a free institution by article IX, § 5 the California Constitution (Free School Guarantee); and

WHEREAS, public education is defined as the learning provided within the prescribed state education curriculum; and

WHEREAS, curriculum within California public schools is discussed and submitted by teachers and district officials then approved by Department of Education; and

WHEREAS, fees for basic supplies required to administer said curriculum must be provided at the public's expense; and

WHEREAS, true extracurricular activities are administered after the completion of the school day often without the required funds to cover activities offered; now, therefore, be it

RESOLVED by the Student Congress here assembled, that co-pays and fees required for participation in activities after the end of a school day do not violate the Free School Guarantee and are not subject to audits or the formal complaint process under AB 1575.

A Resolution Regarding Welfare

WHEREAS, numerous individuals who are in poverty and who receive government assistance abuse drugs; and

WHEREAS, this assistance is meant to provide aid to help raise families, provide food to those in need, and aid in job assistance; and

WHEREAS, the use of drugs tends to hinder the effect of assistance; and

WHEREAS, numerous individuals in welfare programs continue on welfare programs due to drug abuse; and

WHEREAS, this continued stay results in the waste of more government and taxpayer money; now, therefore, be it

RESOLVED by the Student Congress here assembled, that all persons who receive government assistance of any kind be subject to produce a clean drug test before receiving financial assistance.
